FINANCIAL DIRECTOR

Lynn Vogeltanz: Update on Government Affairs. We did not get the floor vote, next session starts Jan 18th, we are game planning on the strategy on how to proceed. We will be partnering with IIDA. Lynn has asked for a list of where the legislators stand on the bill, we are tracking which legislators are being contacted. We had 400 people contact the legislators, but the lobbyists would like to see the number of contacts closer to 500-600 people reaching out to legislators.

Possible initiatives: Thanksgiving or Holiday sharing campaign, asking for floor time at upcoming events such as the Hotel Indigo tour, asking adjacent organizations for support such as Landscape Architects, postcard campaign, competition for highest QR codes (paying for membership), having Capital Day at end of January
